When a complaint is levied against a housing provider and makes it to a state or federal court, the way the court decides the case provides "takeaways" for the rest of us. The results of court cases are one of the best ways to find out the "Dos and Don'ts" of Fair Housing. We will review recent court cases about the four most frequent areas of complaint: disability, race, sex, and familial status. You will hear the case, make the call, and find out why the court decided the way they did.

We will discuss the takeaways from each case on what we should and should not do in our day-to-day interactions with applicants and residents. The course includes a review of words and phrases to be avoided, used with caution, and those that are considered acceptable when advertising or speaking about your property.
